



2012 BBEDC Area 4E CDQ Halibut Application



Participation is limited to verified residents of a BBEDC community. Vessels used in the 4E halibut fishery must owned by the applicant or by a verified BBEDC community resident. In cases where the fisher does not own the boat to be used, both the applicant and the boat owner must have a current Residency Affidavit on file with BBEDC. Boat length is limited to 32-feet or less. Applicants -- and Boat Owners if applicable -- must also complete the attached Relationship Disclosure form.

You must complete the information below and be sure to carefully read the Harvest Agreement (Part B). **The Harvest Agreement binds you to federal and state halibut regulations and to BBEDC's requirements** for participation in the 4E CDQ halibut fishery, and halibut fishers who violate these regulations and requirements can lose the right to harvest halibut in the CDQ fishery. When you fully understand and agree to the provisions of the Harvest Agreement, initial and date this form in the spaces provided. Contact BBEDC if you have any questions.

Emailed applications are preferred (by clicking Submit), but you may also print and fax, mail or hand-deliver your application to BBEDC. **Applications must be received at BBEDC by April 1, 2012. Copies of any other required documents must be received by May 1, 2012.** These include legible copies of your 2011 CFEC halibut license and 2011 vessel license issued by the State of Alaska. (See Additional Requirements for Direct Marketers, below).

Additional Requirements For Direct Marketers

If you sell halibut anywhere other than to a licensed processor -- such as dock sales to the public -- you must register with the State of Alaska as a Catcher-Seller **and** with the National Marine Fisheries Service as a Registered Buyer **and** you must notify BBEDC of that intent. **(2)** Catcher-Sellers (Direct Marketers) are also required to register with the State of Alaska's E-Landings web site and file catch reports electronically, **and provide BBEDC with your Elandings Log-In and Password.** Providing your login and password is a new requirement intended to avoid problems that in the past have put the 4E CDQ halibut fishery at risk. **Direct marketers who do not comply will lose 4E CDQ fishing privileges.**
